

COPPERPLUS CLAD STRIP 25 year limited warranty

RainTrade Corporation, hereby issues the following warranty:

That RainTrade Corporation CopperPlus clad strip (the "CopperPlus Product") sold for use as metal roofing, siding, fascia, rain drainage, and ventilation components, if erected in the United States, WILL NOT, as a result of corrosion from exposure to normal atmospheric conditions, rupture, fail structurally, or perforate within a period of 25 years after shipment from RainTrade Corporation.

Claim – Under the Guarantee, claims must be made to RainTrade in writing within thirty (30) days after the purchaser becomes aware of the alleged defect. RainTrade must be given reasonable opportunity (which shall not be more than thirty (30) days from the date of receipt of notification to inspect the material claimed to the defective prior to initiation of any replacements.

This warranty DOES NOT APPLY to sheets exposed at any time to corrosive or aggressive atmospheric conditions, including but not limited to:

- 1. Areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, or animal waste.
- 2. Areas subject to water run-off from other metal flashings or areas in metallic contact with such other metals, or severe erosion conditions.
- 3. Conditions and circumstances where corrosive fumes or condensates are generated or released inside the building.

This warranty DOES NOT APPLY in the event of:

- A. Bending or forming where the bend is tighter than 2T for sheet thickness up to 0.030" (0.75mm) and tighter than 4T for sheet thickness 0.031" (0.76mm) and thicker.
- B. This slope of the roof or sections of the roof being flatter than 1/2:12.
- C. Unusual or uneven weathering, defects which are caused by or are the result of improper installation, architectural design of the building, unusual atmospheric or weather conditions, including pollution or harmful emissions, and/or events which prevent formation of or cause removal of the natural occurring oxide film.
- D. Mechanical, chemical, or other damage sustained during shipments, storage, forming, fabrication, or during or after erection.
- E. Forming which involves severe bending or which subjects the coating to alternate compression and tension.
- F. Failure to provide free drainage of water, including internal condensation, from overlaps and all other surfaces of the sheets or panels, or any cosmetic staining that may occur on the CopperPlus Product.
- G. Failure to remove debris from overlaps and all other surfaces of the sheets or panels.
- H. Damage to the metallic coating caused by contact with green or wet lumber.
- Deterioration of sheets or panels caused by contact with green or wet lumber.
- J. Wet storage stain caused by water damage or from condensation.
- K. Presence of damp insulation or other corrosive materials in contact with or close proximity to sheets or panels.
- L. Deterioration of sheets or panels caused directly or indirectly by contact with fasteners. The selection of suitable long lasting fasteners to be used with CopperPlus Product roofing, siding, gutter and downspouts rests solely with the Buyer.

This warranty shall be subject to the stipulations, limitations and conditions hereinafter set forth:

- 1. RainTrade Corporation liability for breach of this warranty shall be limited exclusively to the cost of either repairing nonconforming sheets, panels, gutters and downspouts, or at RainTrade Corporation sole option, furnishing FOB Buyer's plant sufficient CopperPlus Product to enable Buyer to fabricate replacements for the nonconforming panels, gutters and downspouts.
- 2. RainTrade Corporation shall not in any event be liable for the cost of labor expended by others on any nonconforming sheets or for any special, indirect or consequential damages to anyone by reason of the fact that such sheets shall have been nonconforming.
- 3. Claims must be promptly reported in writing to RainTrade Corporation, and He shall be given a reasonable opportunity to inspect the sheets, panels, gutter and downspouts claimed to be nonconforming adequate identification of the material involved in the claim, including the date of installation, order number, coil number, invoice number and date of shipment must be established by the Buyer.
- Buyer shall exercise diligence in the inspection of material as received from RainTrade Corporation so as to mitigate repair or replacement.
- RainTrade Corporation reserves the right to terminate this warranty at any time (except as to orders already accepted) upon the giving of written notice thereof.
- 6. All warranty disputes will be settled under applicable laws of Illinois.

RAINTRADE CORPORATION MAKES NO GUARANTEES, EITHER EXPRESSED OR IMPLIED, BEYOND THE FACT HEREOF: INCLUDING, WITHOUT LIMITATION, WARRANTIES OF FITNESS AND MERCHANTABILITY AND SHALL HAVE NO OTHER LIABILITY WITH RESPECT THERETO.
